In fact, proposed modifications to the ISN/RPS lupus nephritis classification included TMA. Capillary and arteriolar thrombosis.

I found the main module to be poorly structure and lacking detail. While this module was good to provide some assistance with the conceptualization of NPSLE I didn't think there was adequate detail about the individual manifestations. Possibly with the exception of cognitive impairment, headache and myelitis. Certain topics (aseptic meningitis) were not covered at all. A longer, more details module would be appreciated in future.

A deep explanation should be done about CSF exam in NPSLE with differential diagnosis with other neurological disorders.

Both in ICC-1 and in self-assessment (question 7), an error in evaluating correct answers was present (there was contradiction between those showed as correct answers and effective explanation given). For example, in question 7 of self-assessment, the answer "antibiotics" is showed as correct, but in explanation it's showed as wrong (and it's actually wrong, but score was unfairly reduced).


